

**DISPOSITION CODES TO BE USED IN MUNICIPAL COURTS**

<b>OLD CODE</b>	<b>DESCRIPTION</b>	<b>NEW CODE</b>
NP	<b>Dismissed</b> when the city attorney or prosecuting officer declares <b>before trial</b> his or her intent not to prosecute the charge(s).	<b>1A</b>
DM	<b>Dismissed</b> by the judge when time has expired to prosecute the charge(s).	<b>1B</b>
--	<b>Dismissed</b> by the judge for some reason other than time has expired.	<b>1C</b>
GP	<b>Guilty</b> when the defendant pleads guilty or no contest <b>before trial</b> and is given any sentence other than a deferred sentence.	<b>1D</b>
--	<b>Guilty</b> when the defendant enters a plea <b>before trial</b> and is given a deferred sentence but it is not yet known whether the defendant has complied with the conditions of deferment.	<b>1G</b>
CI	<b>Dismissed</b> when the defendant makes a plea <b>before trial</b> and is given a deferred sentence and successfully complies with the conditions of deferment.	<b>1H</b>
CC	<b>Guilty</b> when the defendant makes a plea <b>before trial</b> and is given a deferred sentence but fails to comply with the conditions of deferment.	<b>1J</b>
TF	<b>Dismissed</b> when the case is transferred to District Court for Competency Hearing.	<b>1K</b>
--	<b>Dismissed</b> when the defendant produces a valid driver's license or proof of financial responsibility valid at the time of issuance of the citation per the applicable municipal ordinance	<b>1M</b>
DL	<b>Dismissed</b> for failure to prosecute when the officer fails to appear at trial.	<b>1N</b>
--	<b>Dismissed</b> when the charges from a related/companion case are consolidated (i.e., the charges are entered) into another criminal case (i.e., the primary case). Use this code at the time of consolidation and only on the charge(s) previously entered in the related/companion case.	<b>IP</b>
NA	<b>Dismissed</b> when the defendant is found not guilty of the charge(s) by a judge <b>during or after a bench trial</b> .	<b>3A</b>
DT	<b>Dismissed</b> when the judge or city attorney or prosecuting officer dismisses the charge against the defendant <b>during or after a bench trial</b> .	<b>3B</b>
--	<b>Dismissed</b> when the city attorney dismisses the charge(s) or fails to re-try after a mistrial in a bench trial.	<b>3C</b>
GT	<b>Guilty</b> when the defendant makes a guilty or no contest plea and is given any sentence other than a deferred sentence <b>during a bench trial</b> .	<b>3D</b>
--	<b>Dismissed</b> when the defendant is convicted of a charge or pleads to a charge <b>during a bench trial</b> , is given a deferred sentence, but it is not yet known whether the defendant has complied with the conditions of deferment.	<b>3G</b>
CI	<b>Dismissed</b> when the defendant is convicted of a charge or pleads guilty to a charge <b>during a bench trial</b> , is given a deferred sentence and successfully meets the conditions of the deferment.	<b>3H</b>
CC	<b>Guilty</b> when the defendant is convicted of a charge in a bench trial or pleads guilty to a charge <b>during a bench trial</b> , is given a deferred sentence but fails to comply with the conditions of deferment.	<b>3I</b>
NC	<b>Guilty</b> when the defendant is found guilty by a judge <b>during or after a bench trial</b> and is given any sentence other than a deferred sentence.	<b>3J</b>
--	<b>Dismissed</b> by the judge when a witness failed to appear.	<b>3L</b>

- DO      Dismissed before trial without prejudice
- DW      Dismissed before trial with prejudice
